## **Notice for Procurement of Works**

(First Date of Publication: 2070/08/21)

- 1. Government of Nepal (GON) has allocated a part of its budget toward the cost of Medium Irrigation Projects and intends to apply part of this budget for the payments under the Contract for the construction of Ghuiyabari Irrigation Project, Kaprichaur, Salyan.
- Mid Western Irrigation Development Sub Division No. 2, Khalanga, Salyan, Mid Western Regional Irrigation Directorate, Department
  of Irrigation on behalf of GON, invites sealed bids from eligible and qualified bidders under National Competitive Bidding.

- 4. A complete set of Bid Documents may be purchased from Mid Western Irrigation Development Sub Division No. 2, Khalanga, Salyan by eligible bidders on the submission of a written request along with copies of the company/firm registration certificate, renewed License, PAN and VAT registration certificates, income tax clearance certificate upto FY 069/070 upon payment of a non-refundable fee as listed below on or before 30<sup>th</sup> day of date of publication of this notice. Bidder's representative who wishes to purchase the bid document shall furnish authority letter issued by the authorized person of the firm or JV firm.
- 5. The sets of documents can also be downloaded from DOI's website. The fee of bid document may be paid either depositing it in account of District Treasury Office, Salyan account no.: Ka-1-1-004, Rajashwa Shirshak no.: 14227, Office code no.: 61-357-01 at Nepal Bank Limited, Khalanga, Salyan or by paying cash at MWIDSD No.2, Salyan office. In case of e-submission, the bank voucher or cash receipt must be also attached. The name of depositor in voucher of the cash deposit for the cost of bidding documents should be the name of bidder/bidders (in case of JV) itself. If the name of bidder and name of depositor differs, the bid shall be considered as non responsive.
- 6. The completed documents must be submitted to Mid Western Irrigation Development Sub Division No.2, Khalanga, Salyan on or before 12.00 hours (Noon) of the next day of the last date of purchasing. Should the last date of purchasing/submission fall on a GON official holiday, the next working day shall be considered as the last date of purchasing/submission. The documents received after this deadline will not be accepted.
- 7. The bidders who choose to submit the bids by e-bidding system should submit the original copies of mandatory documents to MWIDSD No.2, Salyan within 7 days of last day of bid submission.
- 8. The bid documents will be opened in presence of the bidders or their authorized representatives who choose to attend at the above mentioned address at 14:00 hours on the last day of submission. The bid & qualification documents shall be evaluated according to Public Procurement Act 2063/ Public Procurement Regulation 2064.
- 9. The substantially responsive bidders (themselves or their authorized representative) shall have to produce their original documents (work experience certificates, financial statements and owner's books for all proposed plants, equipment and vehicles including those being leased or rented etc. as demanded by the document) for verification as and when asked by the Mid Western Irrigation Development Sub Division No.2, Khalanga, Salyan.
- 10. Bids must be accompanied with an earnest money of 2.5% of the Bid amount in the form of Bank Voucher deposited in. Kha- 3 (Dharauti) account no.: 074020000300 at Nepal Bank Limited, Khalanga, Salyan or Bank Guarantee drawn in favour of Mid Western Irrigation Development Sub Division No.2, Khalanga, Salyan having a validity period 120 days from the last date of submission of bid document. Bank Guarantee issued by any Finance Company will not be accepted. Bids shall be valid for a period of 90 days from the deadline of bid submission.
- 11. Should any of the information data submitted by the bidder in the documents be unclear and not substantiated by supporting documents, such information shall not be considered for evaluation.
- 12. Bidders are requested to visit the site and assess the actual site conditions before submitting their bid.
- 13. The unit price furnished in words shall prevail in case of any discrepancy between figures and words.
- 14. The Mid Western Irrigation Development Sub Division No.2, Khalanga, Salyan reserves the right to accept or reject any or all bids or to annul the process without assigning any reason whatsoever.
- 15. Any Bidder may apply for the work either by himself or as a partner in joint venture provided that each J/V partner has purchased a complete set of bid documents separately. However, if joint venture documents are produced during purchasing the documents, the joint venture firm will be treated as a single entity and the J/V partners need not purchase the set of documents separately.
- 16. Any amendment in the Tender Notice shall be published in the Notice Board of Mid Western Irrigation Development Sub Division No.2, Khalanga, Salyan and DOI's website.
- 17. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063, Public Procurement Regulation-2064 and Prevailing Law and Regulation.
